V1 stated that S1 exited his vehicle and was cursing belligerently at V1 for blocking the handicap parking spot and yelling that he was disabled. V1 stated that S1 then pushed him twice before leaving the area. S1 then pulled into oncoming traffic on Palm Coast Parkway and struck a family head-on causing severe damage to both vehicles. FHP responded to work the DUI/Crash due to high call volume. The female scratched the male, then grabbed a hose and started squirting the male with water, then the male reacted and pushed her in the bushes. Female was arrested for Battery (domestic).

Statements were obtained and DV paperwork was issued to V1. It was determined based on statements that S1 was the primary aggressor and a 707 affidavit was completed, charging S1 with DV battery.
