Domestic Disturbance/ 2017-81428/ Emerson Drive, Palm Coast/ Sector 226/ V1 stated that S1 pushed her down during an argument causing visible injuries. S1 was located and was taken into custody without incident. S1 was arrested in reference to domestic battery and V1 was provided all Domestic Violence paperwork. See report by Deputy G. Domestic Disturbance/ 2017-81424/ Flanders Lane, Palm Coast/ Sector 212/ Verbal altercation between two parties during which time both subjects were being childish and threw the other's cell phone into the family pool.
