A fake bill of sale was then created and the vehicle was advertised on Facebook for sale for \$9,000.00. W1 saw the listing and contacted S1 and S2 for a test drive. He took the vehicle to his residence and then located a "Beaver Toyota" sticker hidden under another sticker that S1 had placed on the rear of the vehicle. S1 contacted the dealership to inquire about the vehicle. It was at that time the dealership became aware the vehicle was stolen and the dealership and W1 contacted law enforcement. Both subjects were arrested for dealing in stolen property and organized scheme to defraud. SJSO is obtaining warrants for grand theft motor vehicle.
