16156-18	2/19/2018	Animal Bite - O1 was bitten by a dog as she was breaking up a fight between her dog and another. Rescue provided aid on scene and she was not transported. Animal control was notified.
18-16006	2/19/2018	Disturbance Domestic - *FOLLOW UP* 707 Charging affidavit was passed on by night shift. Deputies responded to the residence and placed S1 under arrest.
18-16143	2/19/2018	Burglary Residential - V1 stated on 2-19-18 at 0500 hours he went outside and noticed the open garage door at which time he closed the door. At 0900 hours he went to his vehicle and noticed both doors on the driver side were slightly ajar as it was left unlocked.
16147-18	2/19/2018	Disturbance Domestic – S1 arrested for aggravated assault, felony battery-domestic battery by strangulation, aggravated child abuse, and obstruction of justice-resisting arrest without violence.

All stolen items were sitting on the living room couch next to the front door. V1 said he left for work at 0700 hours and when he came home for lunch he noticed that the front door was ajar and the items stolen. 16177-18	2/19/2018	Crash with Injuries - Four vehicle crash that shut down west SR 100 for approximately 45 minutes in both directions. The driver of a white Chevrolet Suburban failed to stop and crashed into the last stopped vehicle in a line of stopped vehicles causing a chain reaction. A total of three people were transported via ambulance with varying degrees of injury. FHP responded to investigate the crash.
