The RP stated that his elderly father was inside the residence and possibly in danger. Units attempted contact and eventually entered the home where the suspect barracaded himself in a bedroom. Several people assisted the subject to the ground. Subject continued to resist with violence. A Taser was deployed to subdue the subject. Subject 1 (S1) was apprehended northbound on U.S. 1, arrested for two warrants, driving while license suspended and battery DV.

02-17-16/14:58/Zone 4/Disturbance Domestic/2016-14427/Parkview Drive, Palm Coast. A mother reported that her juvenile son physically attacked her and knocked her down. S1 is on probation for DV battery. He was arrested and transported without incident.
