The RP stated that his elderly father was inside the residence and possibly in danger. Units attempted contact and eventually entered the home where the suspect barricaded himself in a bedroom. Several people assisted the subject to the ground. Subject continued to resist with violence. A Taser was deployed to subdue the subject. He was arrested reference domestic battery and Baker Act paperwork was turned over to FCIF. See report by Deputy Bell and Response to Resistance forms for further.

02-17-16/09:38/Zone 4/Disturbance Domestic/2016-14324/ Ryken Lane. RP had called earlier in reference to a verbal argument with her boyfriend, Randy Day. He had left prior to LEO arrival. Later, she reported that Randy had punched her in the stomach and stomped on her leg. Subject 1 (S1) was apprehended northbound on U.S. 1, arrested for two warrants, driving while license suspended and battery DV.

02-17-16/14:58/Zone 4/Disturbance Domestic/2016-14427/Parkview Drive, Palm Coast. A mother reported that her juvenile son physically attacked her and knocked her down. S1 is on probation for DV battery. He was arrested and transported without incident.
