### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance Domestic / 16-38246 / Lancewood Street - Victim reported that she was grabbed by the hair during an argument in a vehicle. She walked away from law enforcement while the investigation was still being conducted, refusing to cooperate further. See report by Deputy Beausoleil for further.

Burglary Residential (Occupied) / 16-38299 / Bird Haven Place, Palm Coast. Victim reported upon returning home and once inside his residence, he observed Maurice Godwin inside his residence and watched as he ran out the front door. Further investigation revealed Godwin was in the process of rummaging through the master bedroom as the victim was entering his residence. Godwin then fled the scene in a vehicle and was later apprehended on Highway 100 West by Balyor Farms after crashing his vehicle. While fleeing the scene, Godwin ran over the mailbox at 2 Bird Haven Lane. Godwin was charged with burglary of an occupied dwelling, petit theft, criminal mischief, possession of burglary tools, possession of cannabis under 20 grams and fleeing and eluding. Godwin also had a writ of bodily attachment out of Alachua County and was on probation for possession of cannabis over 20 grams, inmate release for burglary and is a Florida career offender. Godwin was additionally charged with felony VOP. See report by Deputy R. Finn for further.
