### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Water Rescue-Baker Act/ 16-038755/ Jungle Hut, Flagler County. Kayaker advised the VA that he was going to paddle out into the ocean and drown himself. The Kayaker was spotted nearly a half mile offshore travelling in a north eastern direction paddling away from land. FireFlight responded to assist as PCFD Marine Rescue went out on jetski to attempt contact. The Kayaker was initially uncooperative and exited the Kayak numerous times and also capsized it. Due to the circumstances, assistance of the Coast Guard was initially requested as well as VCSO who had a boat in the water and were willing to respond. FCSO Marine Unit made contact with FWC who also had a boat in the water and were responding. PCFD was able to get the Kayaker to shore in the area of 40 Ocean Ridge Blvd N in Cinnamon Beach where he was taken into protective custody by FCSO without further incident. All requests for outside assistance were cancelled. The original location provided by PCFD was the area of the beach behind 20 Ocean Ridge Blvd N in Cinnamon Beach.
