Stabbing / 2016-63305 / Zenoble Place, Palm Coast. Reporting Person (RP) advised that her son Victim 1 (V1), had been stabbed in the throat. Upon arrival, a large laceration was found to the left side of his neck and he was transported via EMS to Halifax Health Medical Center, Daytona Beach. The home showed several signs of a struggle. Criminal Investigation Division was notified and Detective Blanton responded to the scene. He was able to conduct an interview with V1 at Halifax, where V1 claimed that he fell, causing the injury. Burglary Residential / 2016-63298 / Pine Grove Drive, Palm Coast. RP stated as he drove past the residence, he observed several subjects in front and on the side of the house. RP also heard glass breaking; he turned around and then observed an unknown vehicle leaving with the lights off. Deputies found broken windows.
