Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Attempt (vehicle)/ 16-70937/ Ryecliffe Drive, Palm Coast. Victim 1 (V1) advised he saw three males, one described as a tall thin w/m with a backpack, opening his car door. He confronted them and they left. Nothing was reported stolen. No suspects could be located. No additional victims were located.

Disturbance Domestic/ 16-70882/ Bracken Lane, Palm Coast. Units responded to the above location for a disturbance. Subject 1 (S1) (Charles Sobczak w/m 8-19-61), ignored multiple commands to stop and tried to flee out the rear of the residence. He surrendered without incident. Investigation revealed he had pushed his daughter V1 and punched his wife V2 in the face. S1 was arrested for Resisting without violence and 2 counts of Battery Domestic Violence. Report by Dep. Marchman Act/ 16-70933/ Cypress Point Pkwy, Palm Coast. The clerk at the Smoker's Express stated a male had stumbled out of the bathroom bleeding. He was found lying on the sidewalk after he fell down and injured his face. He was living in his car with his girlfriend (Lacy Gunter w/f 9-26-87). She was arrested on an out of county warrant for FTA. He was taken into custody under the Marchman Act.
