9-12-15/ 10:45p/ Zone 4/ Suicide Attempt/ 94485-15/ Rycast Lane, Palm Coast. Subject who was intoxicated and having life issues, armed himself with a knife and told his sister-in-law he was going to harm himself. Subject was taken into custody and transported to CTTU without issue.

09-13-15 / 2:36am / Zone 4 / Domestic Disturbance / 94526-15 / Wellstream Lane, Palm Coast. Reporting party and her husband got into a verbal disturbance that turned physical when S-1 struck and pushed V-1. The father of V-1 saw the disturbance become physical and intervened. W-1 suffered several cuts and bruises to his face. S-1 then ran off before LEO arrival. Neither party wanted to pursue charges. However, a deputy did sign charges for domestic battery, which will be held for the remainder of the weekend, if S-1 returns.

09-13-15 / 2:51am. / Zone 2 / Domestic Disturbance-Crash / 94525-15 / Fleetwood Drive, Palm Coast. Anthony Bechtel (S-1) came home intoxicated and started an argument with his live-in girlfriend, V-1. Bechtel then became physical and grabbed the victim by the neck. Bechtel then threw a knife at the victim while she was on a couch. The knife did not hit the woman. Bechtel then got in his vehicle and drove, returning moments later, where he crashed into a telephone pole in front of the house. He did not sustain any serious injuries. He was arrested for aggravated assault and battery domestic.
