Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Stolen Vehicle/ 17-448/ Wellwood Lane, Palm Coast/ The reporting person (RP) stated her brother, Subject 1 (S1) took her keys and stole her vehicle. Report by Dep. Casey.

Disturbance- Physical/ 17-450/ Coconut Boulevard, Palm Coast. Four adults were involved in a physical disturbance. How the fight got started is unclear due to multiple conflicting stories. It was established that no violence occurred that would constitute domestic violence. All parties declined to have charges pressed and two parties left for the evening. Baker Act/ 17-445/ Berkshire Lane, Palm Coast. A woman reported that she received threatening messages from a male friend via Snapchat. The RP said the subject sent video messages depicting himself acting disoriented. He also was suicidal. The subject was located near his home and was taken into custody without incident. Disturbance Verbal/ 17-497/ Riviera Estates Drive, Palm Coast. An RP called 911 and advised he had been threatened at gunpoint by two white females and two black males in a pickup with the males riding in the bed. Cpl. Miller located a vehicle fitting the given description. A felony stop

While units were enroute, caller advised that she lost consciousness and was no longer breathing. Attempts to resuscitate were unsuccessful and she was declared deceased.
