Upon arrival, deputies found a female in the back yard suspended from a small tree by a belt tied around her neck. Deputies cut the female down and Med Rescue began life-saving efforts. The female was transported to FHF via Med Unit. No one else was at the residence. The property was taped off and a crime scene log was initiated.
