#### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Residential/96360-16/Birchwood Drive, Palm Coast / Zone 3/ Victim 1 (V-1) came home to find a male in her residence. V-1 fled to a neigbor's house and called 9-1-1. The suspect (S-1) was seen getting into a vehicle being driven by another subject (S-2). Both suspects and the vehicle were located and taken into custody. S-1 was identified as David Willett; S-2 was identified as Alex Haggett. Call still active.

Disturbance Domestic/96388-15/ Bridle Path Lane, Ormond Beach /Zone 6/ V1 reported that her boyfriend, S1-Howard Bell 9-29-76 hit her and then threatened her with a machete. While law enforcement was enroute to the residence, S1 reportedly threw the machete at V1 without striking her. S1 fled into the woods as deputies arrived on scene. VCSO assisted with K-9 and back-up. S1 was located by VCSO K-9 where he was arrested for aggravated assault with a deadly weapon, battery, and resisting without violence.
