### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Missing Person/99629-16/ Ulbright Court, Palm Coast, Zone 6 / The reporting person (RP) reported that her ex-husband, Missing 1, (M-1) has been missing since approximately 10/24/2016. RP advised that this is out of character for M-1. M-1 was entered into state and national databases as missing.

Stolen Vehicle/99718-16/I-95 north of Palm Coast Pkwy, Palm Coast / Off-duty law enforcement officer (Daytona PD) observed a white 4 door Toyota Camry reported stolen (from Pinellas County) on I-95. Motor units spotted the vehicle and conducted a felony stop and secured one male. The entering agency was notified, Defendant 1 (D-1) Micky Franklin Hollihan W/M 11-16-62 was transported to the FCIF, and the vehicle was towed from the scene. Report made.

Stolen Vehicle- Recovered/Hargrove Grade and Otis Stone Hunter Road, Espanola, Zone 7/ Deputies observed a white Chrysler 300 driving erratically in the area. Units recognized the vehicle as a stolen vehicle which had fled from LEO earlier in the week. Deputies attempted to catch up to the vehicle to conduct a traffic stop. The vehicle was subsequently located, unoccupied, at said intersection. A perimeter was established and K-9 was deployed. FireFlight also responded to the scene and assisted. No suspects were located. The vehicle was towed to the FCSO impound to be processed.
