10-01-15/9:13pm/ Zone 7/ Burglary Residential/ 2015-101037/ County Road 305, Bunnell. A victim stated that sometime between September 26, 2015, and October 1, 2015, at about 7 p.m., someone entered his residence and removed several items. V-1 said someone removed 2 laptops (1 HP and 1 Toshiba). He stated that he is also missing \$3,800 in cash that was locked in a chest in his closet. Scene was not processed due to the delay in reporting.

10-1-15/7:30pm/Zone 4/Follow Up (Grand Theft)/2015-101015/ Wellington Drive, Palm Coast. Reporting person (V-1) reported that some unknown person had removed a bag containing four firearms from beneath his bed. He was able to provide the following descriptions: one Mauser-Werke AG .380 caliber semi-automatic pistol worth \$200; one Browning Arms 9MM semi-automatic pistol, \$200; one Colt Arms WW1 .38 caliber revolver, \$200. Also reported stolen was one air pistol unknown make or model, \$100.

10-1-15/ 7:46pm/ Zone 3/ Suicide Threat/ 2015-101026/ 2860 Palm Coast Parkway (Heroes Park), Palm Coast. Reporting person called in stating that O1 Timothy Sturman, 36, called her and stated he had a shotgun and was going to kill himself. Subject's phone was pinged to Heroes Park and units located his vehicle at this location. A perimeter was established and voice contact was made but no visual. Volusia County's sheriff's helicopter AirOne responded and located the subject and SWAT also responded to the scene. After lengthy negotiations, O1 surrendered the firearm, exited the woods, and was taken into custody without incident. See report by Deputy Petkovsek for further.

10-1-15/ 5:51pm/ Zone 6/ Domestic Disturbance (Verbal)/ 2015-100993/ Ethan Allen Drive, Palm Coast. A reporting person stated that his wife, O2, struck him on the left side of the neck during an argument. After speaking with O1, O2, and neighbors it was determined that O1 is suffering from dementia and there is no evidence that a crime occurred. DV pamphlets were distributed. O1 has an active warrant and left the scene prior to our arrival. O2 refused to provide a written statement and all parties on scene agreed that both parties agreed to fight each other.
