While investigating a suspicious incident (FCSO case # 15-106667), it was discovered that an unsecured vehicle at this location had been broken into. Because V1 was not available, contact was made with his daughter / O1, who confirmed that nothing had been taken from the vehicle. See report by Deputy Cowan.

10-19-15 at 12:37am / Zone 3 / Stolen Vehicle (Recovered) & Car Break / 15-106692 / Barrington Drive, Palm Coast. While investigating a suspicious incident (FCSO case # 15-106667), Deputy J. Kuleski observed 3 black males exit a vehicle in front of 31 Burning Bush Drive. When he attempted to make contact with the males, they ran toward that residence, home of a known subject. Contact was made with subject's mother / O1, who denied any males had run into her home and could not explain who had parked the vehicle in front of her residence. Further investigation revealed the vehicle, which the males exited, is registered to an owner on Barrington Drive. Contact was made with the registered owner / V1, who confirmed the vehicle had been stolen from his driveway. V1 also reported a second, unsecured, vehicle at this location had been broken into. The key for the stolen vehicle was removed from this unsecured vehicle. Both vehicles were processed and turned over to V1. A cellphone belonging to S2 was located within the vehicle.
