Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Residential/ 16-106050/ Woodstone Lane, Palm Coast/ Victim 1(V1) advised he left his residence around 12pm and returned around 2:30pm to find the home burglarized. Suspicious Incident/ 16-105935/ Radcliffe Drive, Palm Coast/ V1 advised a black male forced entry into the home, there was a physical conflict and the male fled on foot. Perimeter established, K9 and ISD responded. No signs of forced entry. The subject was not located. After interviews the call type was changed to a suspicious incident when the subject advised he heard a noise, saw the subject standing in the open doorway, and initiated a physical confrontation.
