### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Crash with injuries/102617-16/I-95, mile marker 285 / A trailer hauling construction debris became unlatched from a truck that was traveling southbound on I-95. The trailer then damaged the median guardrail and went into northbound lanes. Several cars traveling northbound were damaged but there were no life threatening injuries. FHP took over the investigation and Fire Police established traffic control.

Missing Person-Juvenile/102691-16/Unimay Court, Palm Coast / Zone 5. A juvenile ran away after his mom punished him for being disrespectful and for issues at school. Call still active.

Animal Problem/102692-16/Intracoastal across to Palm Coast Marina / RP advised he saw a dog swim across the Intracoastal and was lying under the seawall stuck on rocks behind a home under construction in Yacht Harbor. Law enforcement was assisted by a nearby boater and rescued the dog with the assistance of Animal Control. The light brown, medium-sized pitbull mix was transported to the Flagler Humane Society.
