Subject 1 (S1) Joseph Samuel w/m 6-13-93) was arrested on an active local felony warrant at an apartment after a reporting person (RP) reported his juvenile daughter was missing and possibly with S1. Joseph was located hiding in a closet and arrested on the outstanding warrant. The female was recovered and returned to her father. Report by Dep Yeoman.

Disturbance- Physical/ 16-115774/ Westfield Lane, Palm Coast. S1 Erik Prieto was arrested for battery after spitting on his landlord during an argument over the rent. Report by Deputy Cavas.

Disturbance Domestic/ 16-115812/ Fernwood Lane, Palm Coast. V1 and her teen daughter returned home from the grocery store and S1 (George L. Uzzell), her live-in boyfriend, began an argument, where he made several threatening statements, then pushed her down and dragged her by her hair. S1 was arrested for DV battery and Dv Assault. Report by Dep. Butler.

Disturbance Domestic / 16-115807 / Beech Blvd., Palm Coast / Disturbance between a mother and a mentally challenged child. Unable to determine the aggressor and after interviewing all parties, there were numerous discrepancies in the story. DCF was notified and all parties separated for the evening. See report by Deputy Dawson.

Overdose/Poisoning/ 16-115831/ Farrington Lane, Palm Coast. A mother found her adult son unresponsive. The son was resuscitated and transported to FHF by Rescue 22. A plastic bag containing a white powder substance was located near where the son was located. This substance was seized and submitted to FCSO evidence for destruction. Report by Deputy Cavas.
