Missing 1 (M1) has run away in the past and is believed to be hanging out with friends. Possible locations are unknown. Narcotics/116768-16/ Fort Caroline Lane, Palm Coast. A vehicle was driving east on Palm Coast Parkway; attempted stop, took off, deactivated emergency lights at Fleetwood and Old Kings due to erratic driving pattern. Minutes later, subject called and said vehicle crashed on Fort Caroline Lane. Arrived on scene: Vehicle still running, no occupants, drugs in plain view. A man who claimed to be the RP, arrived and became combative with deputies and acting erratically. He was detained for investigative purposes and for officer safety until it was determined he was not involved in this incident. The subject was in possession of two firearms; further investigation will be completed. The guns and narcotics were taken as evidence pending further investigation. Report by Deputy Thomas.
