### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Attempt/ 16-117569/ President Lane, Palm Coast. Tenants returned home after being gone for the holiday to find a rear window broken out. It appears entry was attempted through a rear window but the subjects left prior to entry. Nothing was reported missing. Report by Dep. Cavas.

Disturbance Domestic/ 16-117505/ Rose Drive, Palm Coast. / Victim 1 (V1) advised her ex-boyfriend, who used to reside with her, Subject 1 (S1) Matthew Johnson 7-27-86, coaxed her into his vehicle, then began driving in excess of 100 mph and began making threats to flip the vehicle and kill V1. S1 also prevented V1 from calling 911 during the incident. S1 was located and arrested for domestic battery, aggravated assault, tampering with a victim, and false imprisonment. Report by Dep.
