The Reporting Person (RP) advised he was stabbed in the neck by one of the patients at the group home (for patients with mental disorders). The victim had a cut on his neck and was transported locally for treatment with no life-threatening injuries. The suspect was found near 121 Farragut Drive and Old Kings Road with the knife and complied. The suspect was placed under a Baker Act and charges will be filed with the State Attorney's Office.
