Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Larceny-Shoplifting/111279-16/Cypress Point Parkway (WalMart), Palm Coast /Zone 3 / Defendant 1 (D-1) Tyler Kuback was arrested for shoplifting. D-1 was witnessed by loss prevention associates stealing approximately \$217.44 worth of merchandise. A search of D-1 revealed various prescription pills. D-1 was also identified as a suspect in a theft of jewelry from the store on 12/3/16 (111305-16) and D-1 was wearing stolen jewelry from the theft, total value of \$528.00. D-1 was arrested on both thefts and possession charges and transported to the Flagler County jail.

Follow Up/111079-16/ Boulder Rock Drive, Palm Coast /Zone 3/ D-1 Estuardo Obregon (H/M DOB 4/18/94) was located and arrested for Aggravated Battery Domestic (Pregnant Victim) and Felony Violation of Probation, from a previous incident on 12/3/16. D-1 was transported to the Flagler County jail without incident.

Burglary Commercial/111302-16/Hollar & Green, C.R. 305, Bunnell, Zone 7 / Deputy Prevatt observed headlights near the loading dock of the business as she was approaching. When deputies arrived at the business, the vehicle had already left the area. Deputies discovered that the cooler bay had been burglarized. A pallet of white potatoes and seven Christmas trees were reported stolen.

Disturbance-Domestic/111342-16/Cute Court, Palm Coast/ Zone 2/ Physical disturbance between Subject 1 (S-1), his girlfriend, Other 1 (O-1), his aunt and uncle. S-1 was reported to be the primary aggressor and has a no contact order from a previous domestic incident with O-1. S-1 left
