Once contact was made with her inside, she came outside unarmed and advised she told him he could come get his stuff but do not try to come in her room or she would shoot him. We took the firearm and placed it into evidence for safekeeping, did a standby for him to get his things and he left for a few days until they were calm enough to talk. She reported that she never wanted to harm herself and only feared him because they had been arguing and there had been violence in the past.
