Death / 17-15588 / Rose Drive, Palm Coast /A man was found deceased by law enforcement during a welfare check. No evidence of suspicious activity found during the investigation. Next of kin notified via Orlando PD. See report by Deputy Crego for further.

Disturbance Domestic / 17-15562 / Cypress Edge Drive, Palm Coast. Physical disturbance between a man and his ex-wife. Each identified the other as the primary aggressor. Due to lack of independent witnesses, inconsistencies from subjects involved and both subjects are no longer married nor reside together, charges will be filed against both and forwarded for review.
