Disturbance-Physical/16292-17/Cypress Point Parkway, Palm Coast/ Zone 3/ Defendant 1 (D-1) Daniel Kennedy (w/m 1/14/99) and his brother D-2, a juvenile, were arrested following an altercation at Wal-Mart.
