## Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Suspicious Person/10745-17/ Greenway Court, (Linear Park), Palm Coast / Zone 2 /Contact was made with Subject 1 (S-1) at the park while investigating a narcotics complaint. S-1 was found to have a possible out-of-county warrant for Aggravated Assault. S-1 fled on foot, a perimeter was established and K-9 was deployed with negative results in locating S-1. Report made. Charges will be forwarded for Resisting Arrest w/o Violence.

Warrant Service/10781-17/ Blueberry Street, Bunnell / Zone 7/ Deputies were conducting surveillance to locate S-1 Richard Z. Westervelt W/M 7-16-91, with active Flagler County warrants. A vehicle that S-1 has been known to drive left the residence. Another deputy in the area attempted to stop the vehicle after it ran a stop sign. The vehicle immediately accelerated and fled from the deputy. Seconds later, the units on Blueberry Street could hear a vehicle accelerating toward them. Stop sticks were deployed. S-1 avoided the stop sticks and pulled into the driveway. The deputies ran to the vehicle and ordered S-1 to exit. S-1 lost control and swerved into an FPL pole in the yard. S-1 rant from the crash but was caught by Deputy Gomez after a short chase. Deputy Prevatt secured the female passenger, S-2, Cassidy Wilson W/F 8-12-94. S-1 was arrested for the outstanding warrants, fleeing and eluding, possession of methamphetamine possession of less than 20 grams of marijuana and resisting arrest without violence. S-2 was arrested for possession of a concealed weapon (brass knuckles) and possession of less than 20 grams of marijuana.
