2-9-16/11:34pm/Zone 6/Assist Other Agency/ 11835-16/ Old Moody Blvd., Bunnell. FCSO units responded to provide backup for Bunnell PD to an armed burglary in progress. As BPD officers arrived on scene, they heard gunshots and observed a male, armed with a handgun, leaving the reporting party's residence. FCSO units assisted. The male, later identified as Defendant 1 (D-1) Grant Dewayne Gieger W/M 2-28-86, refused to stop and drop the weapon. At some point D-1 tossed the revolver into a lawn. He then pulled out a knife and threw it to the ground before turning toward deputies and challenging them to fight him. BPD successfully deployed a Taser and the male was secured without further incident. No one was injured by the firearm. See BPD case # 1863-16 for further.
