Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Vehicle/23971-17/Colbert Lane, Palm Coast /Zone 2/ Victim 1 (V-1) reported that unknown suspect(s) broke a window and stole a purse, wallet, wedding rings and keys. The vehicle was left parked, unoccupied between 9am and 11:30am.

Burglary-Vehicle/ Colbert Lane, Palm Coast /Zone 2/ V-1 reported being away from the vehicle for approximately two hours and found a window broken out upon returning. A purse and binoculars were reported stolen. The vehicle was processed.

Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Suspicous Person/23941-17/Palm Coast Parkway, Palm Coast / Zone 3/ A male made comments to an employee regarding harming other people. The male was stopped in the parking lot and interviewed. The adult male was then placed under a Baker Act.

Baker Act/24045-17/Kim C. Hammond Court House, 1769 East Moody Blvd., Bunnell /Zone 6/ A deputy assigned to the Court Services Division was flagged down in the parking lot and advised that a male in a car had a gun. After additional units arrived, the male was removed from the vehicle without incident. It was determined the male was armed with a pistol BB gun and had threatened/intended to commit "suicide by cop." The male was secured for protective custody under a Baker Act and transported to Stewart Marchman Act in Daytona for treatment and mental health evaluation.
