### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Missing Adult (Recovered) / 17-24552 / Palmwood Drive, Palm Coast / Other 1 (O1) Ines Maisannes was located at Halifax Health Medical Center of Port Orange. She's been there since 3/21/17. No suspicious circumstances. Confirmed by Port Orange Police Department. See supplement report by Deputy Malta for further.

Death / 17-24894 / 30 Bassett Lane - An adult male was found deceased at home. ISD responded. Funeral home removed the deceased. See report by Deputy Cowan for further.

TS / 17-24887 / Elm Avenue, Bunnell/ During a traffic stop of Subject 1 (S1) Vanesa Toro-Sampson, S1's sister S2 Gabriela Toro, exited the residence and interfered with the traffic stop after refusing multiple commands to return to the residence. S2 resisted arrest and pushed Deputy Rainey and attempted to flee back into the residence. While S2 was being handcuffed, S1 approached deputies and struck Deputy Rainey on her back. S1 then fled inside the residence and was later arrested. S3 (Eddie Johnson Jr.), who was a passenger in the vehicle, fled the scene on foot. A small amount of cannabis was located within the vehicle. S1 was also out on pre-trial release and she was additionally charged with violation of pre-trial release. Missing Person Adult / 17-24878 / Pine Tree Lane, Bunnell / O1 Charles Singer, 49, has not been heard from for several weeks.
