Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance Weapons / 2017-25756 / Webelo Place, Palm Coast / Zone 4/ Victim 1 (V1) and Subject 1 (S1) Christina M Sousa W/F 08-24-81, were involved in a verbal altercation inside their bedroom. At some point the altercation became physical when S1 lunged at V1 with a broken butcher knife, causing some scratches on V1's right torso. S1 was arrested and charged with aggravated domestic battery with a deadly weapon. See report by Dep. Santoianni for further.

Disturbance Physical / 2017-25772 / Winterberry Place, Palm Coast / Zone 4/ V1 and S1-Justin Taylor W/M 02-01-94 were arguing. S1 then choked V1 enough to make him struggle for air. After choking V1, S1 began striking V1 with closed fists, causing numerous injuries where V1 was transported to FHF. S1 was arrested and charged with domestic battery by strangulation and aggravated domestic battery. See report by Dep. Miley for further.

Larceny / 2017-25795 / Burnside Drive, Palm Coast / Zone 3/ V1 stated that he brought his Playstation 4 console with two controllers and four (4) games into S1's vehicle. S1 asked V1 to get out of the car and check the brake lights. When V1 exited the vehicle, S1 took off with V1's property. Contact attempted at S1's residence met negative results. Charges for grand theft will be submitted to the State Attorney's Office for review. See report by Dep. Flanary for further.

Larceny / 2017-25760 / Deerwood Street, Palm Coast / Zone 1/ V1 advised he has been purchasing gold and silver bars since 2014. As it arrived, he would store it in a green military sea bag, which was placed inside another bag and locked with a padlock. V1 had a total worth of gold and
