Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance Physical / 2017-26629 / Parkview Drive & Pythian Place, Palm Coast / Zone 4 / Deputies responded to this intersection reference a domestic physical disturbance that occurred on a vacant lot. Victim 1 (V1) stated that Subject 1 (S1) Pariate Moore B/M 12/12/90 accused her of cheating on him and began pushing and hitting her while in the car. S1 continued to push and hit V1 until they got close to Robinson Drive where she was dragged out of the car into woods and struck with both open hand and closed fist in the head several times. S1 also began to choke V1 while continuing to tell her he was going to kill her and throw her body in the creek. Contact was made with S1 at 37 Robinson Drive where he resisted arrest and attempted to flee. S1 was taken into custody. Subject was subdued and charged with domestic battery, domestic battery by strangulation, domestic aggravated assault and resisting arrest with violence. See report by Dep. Santoianni.

Larceny / 2017-26648 / Luther Drive, Palm Coast / Zone 3 / V1 reported she had a package stolen that was delivered via UPS on Oct. 12, 2016, (unknown specific time). The package reportedly contained a Sony Play Station Virtual Reality Headset Launch Bundle valued at \$564.40. See report by Dep. Weston for further.

Disturbance Physical / 2017-26700 / South Riverwalk Drive, Palm Coast / Zone 2 / V1 stated that during an argument, S1-Carmine J Lania W/M 10-19-78 pushed up against her forehead and grabbed her by the throat and began choking her. V1 stated that S1 then kicked her legs out from underneath her, causing her to fall. V1 explained that S1 continued to choke her on the ground, restricting her airway and slammed her head into the ground. S1 was arrested and charged with domestic battery by strangulation.
