17-27666/ Assist Public/ Luther Drive, Palm Coast / A female adult left home and has some mental issues. Female was found on Old Kings Road walking to her friend's house. Subject did not meet Baker Act criteria and was given a ride to her friend's house. Deputy Meehan.

17-27747/ Disturbance Domestic/ Rainbrook Drive, Palm Coast /Original responded for a 911 hang up. Dep. Gonzalez heard a scream and had to make entry. Found juvenile child crying and complaining of injuries. Investigation revealed the mother attempted to discipline 13y/o/a daughter who tried to run away, and the mother tried to stop her, resulting in a brief physical altercation. No probable cause found for arrest. DCF contacted. Parties separated. Report by Dep. Gonzalez.

17-27740/ Crash with Injuries/ Whiteview Pkwy @ Ravenwood Drive, Palm Coast /Two vehicles involved. Road closed for short period of time. Driver of vehicle 1 arrested for DUI (see info. below). Deputy Meehan.

17-27755/ Baker Act/ Pine Circle Drive, Palm Coast /Autistic female secured for a Baker Act after threatening to harm herself with a knife. Brief standoff resulted in her being taken safely into custody and transported to Halifax without incident.
