Domestic Disturbance/2016-34954/ Florida Park Drive, Palm Coast. A man claimed his mother threw water on him during an argument. He claimed his phone was damaged by the water; he was uncooperative. His mother denied those claims as did the uncle on scene. No physical evidence on scene to support the accusations. Report taken.

Disturbance Domestic/2016-34969/ Brookhaven Court, Palm Coast. A man and woman who had been dating got into an argument. The woman reported she went to his house and he broke her phone and pushed her. He said she dropped her own phone and said he did not push her door into her intentionally; he just closed it for her and she didnt want to leave. No injuries; I unable to determine an aggressor no propensity for further violence. She reported from her home.
