Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Larceny/37351-16/Bay Drive at South Lake Drive, Ormond Beach. Zone 6. Charles Samuel Shamburg W/M 3-31-83 was arrested for grand theft and dealing in stolen property after it was discovered that he pawned over \$1000 worth of power tools that were stolen from his employer. A search incident to arrest found a small amount of marijuana and a glass pipe in his pants pocket. The charges of possession of less than 20 grams of marijuana and paraphernalia were added.

Shoplifting/37437-16/Target 5100 SR 100 East, Palm Coast. Zone 5. Three females were observed on video concealing merchandise inside their back packs. Two were apprehended but one left through another exit. The adult involved was cooperative and freely turned over the stolen merchandise. The juvenile was confrontational. When attempting to recover the stolen merchandise from her bag she grabbed the bag and began fighting with deputies. It took several minutes to secure the female in hand cuffs. While attempting to secure the juvenile she kicked a deputy twice in the thigh. Once secured in cuffs she continued to fight by pulling and scratching deputies. A search of her backpack revealed she was hiding stolen merchandise, marijuana, and rolling papers. The juvenile was charged with Battery on Law Enforcement Officer, and Resisting an officer with violence. She was later booked at FCSO jail. The adult was issued a notice to appear.
