Warrant Service / 17-29111 / Blueberry Street, Bunnell / During a felony warrant service, intelligence was received from multiple subjects on scene that Subject 1, Eric Sumner, was within a locked bedroom door in the residence. S1 refused to comply with multiple commands to present himself. With the homeowner's permission, two locks were cut off the bedroom door. S1 began voice communications with us, at which point he stopped responding. The door was forced open by Cpl. Weaver and S1 and S2, Jessica McBryde, were arrested without incident. S1 was charged with resisting arrest without violence as well as his felony warrant. S2 was on felony probation and she was additionally charged with VOP as well as resisting arrest without violence.
