The deceased was turned over to the rotation funeral home service and next of kin was notified. See report by Deputy Priester for further. \*\*\*\*Update\*\*\*While on scene, a neighbor advised deputies that the woman was a suspect in a homicide in Volusia County. ISD was notified and determined that the deceased was arrested in August 2016 for the murder of her husband. The woman had bonded out and was awaiting trial. The on-call detective responded to the scene to document the incident. No other suspicious circumstances surrounded the incident. \*\*\*\*
