Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

D-1 was subsequently arrested reference DUI. Deputy Horler worked the traffic crash and Deputy L. Dawson took the DUI investigation. D-1 was transported to the FCIF for processing without incident.

Death/40712-16/Zone 4/ Raemoor Lane, Palm Coast. A 93-year-old man was found deceased by caretaker. No suspicious circumstances. The Medical Examiner was notified and rotation funeral home responded for removal (Clymer's).

Motor vehicle crash THI/40760-16/I-95 north of Matanzas Woods Parkway, Palm Coast. Single-vehicle rollover (SUV Explorer), 7 occupants, 3 confirmed deceased (2 on scene, 1 deceased at FHF). Four victims were transported to Halifax. Interstate 95 from Matanzas Woods Parkway north approximately 2 miles was shut down due to road debris. One lane opened at 4:20pm to continue northbound traffic. Fire Police established traffic control. Florida Highway Patrol investigated the incident (FHP Case #FHPD160FF017355).
