## Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary-Residential/46708-17/White Hawk Place, Palm Coast/ Zone 4/Reporting Person (RP) advised someone stole his television, desktop computer, and printer. There was no signs of forced entry observed. Report was completed.

### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Traffic Stop/46707-17/Point Pleasant Drive, Palm Coast/ Zone 4/Deputy was in the process of conducting a traffic stop on a motorcycle that was being operated with no tail lights. During the course of the stop the motorcycle lost control and struck a concrete culvert at the end of the driveway. The motorcycle and operator then struck a vehicle that was properly parked in the driveway. The occupant sustained injuries and required transportation to Halifax Hospital. Deputy Tarczewski completed an incident report.

Traffic Stop/46758-17/East Moody Boulevard/South Pine Street, Bunnell / Zone 6/ Deputy Prevatt initiated a traffic stop for excessive speed and swerving. Upon contact with the driver, Suspect 1 (S1) she observed him reaching inside a soft side cooler bag in his lap. Deputy Prevatt was able to see the frame of a firearm within the bag. S1 complied with Deputy Prevatt's commands to empty his hands and make them visible. S1 was secured and a loaded semi-auto pistol was found in the bag. S1 does not have a concealed carry permit and was arrested for carrying a concealed weapon. S1 was additionally charged with DUI.
