#### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Attempt/51727-16/Zone 5/Utah Place, Palm Coast. At about 3:58pm, a general burglary alarm sounding was reported. When deputies arrived, they found all exterior doors secure. When the homeowner arrived, he noticed fresh damage and pry marks on two of the doors. It doesn't appear that anyone made it inside the residence. Scene was processed for evidence because other burglaries were reported in the area today.

Defendant 1 (D-1) Dauna Richelle Killam W/F 2-13-67 was arrested for making a written threat to kill or do bodily injury after she sent a text message to her fiance (V-1) threatening to kill V-1's parents, who were visiting V-1. D-1 was located in the parking lot of the apartment complex.

Disturbance-Verbal/51755-16/ Zone 3/ 1310 Palm Coast Parkway SW, Palm Coast. FCSO units remained at the fire scene of Dunkin Donuts as scene security. D-1 Stephen Clasen was arrested after refusing to obey several commands to leave the fire scene where firefighters were still actively working and the area was taped off. D-1 was charged with two counts of Resisting Arrest without Violence and transported to the Flagler County jail for processing without incident.
