### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary-Vehicle/62537-16/ Faith Lane, Palm Coast. / Zone 2 / Unknown suspects entered an unlocked 2007 Chevrolet Tahoe sometime between 11 last night and 9 this morning. A Michael Kors women's wallet (valued at approximately \$70) that contained cash in it was stolen. The vehicle was processed for prints and a report was made.

Stolen Vehicle/62626-16/Otis Stone Hunter Road/U.S. 1, Bunnell. /Zone 4 / Deputy Jacob conducted a traffic stop on a stolen vehicle at Rolling Sands/Whiteview area and the vehicle fled after stopping momentarily. The stolen vehicle (from Volusia) turned left onto U.S. 1, traveled approximately .4 (four-tenths) of a mile and drove off the roadway at Otis Stone Hunter and U.S. 1. Four subjects were secured for investigation: Gaines Smith Jr. B/M 6-25-97, and three juveniles. Gaines Smith Jr. was arrested for flee and elude, grand theft, and possession of marijuana under 20 grams. Remaining occupants were turned over to their parents and charges will be submitted.

### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Warrant Service/62675-16/ Snowbird Lane, Flagler Beach (Bulow Campground)./ Zone 5/ Defendant 1 (D-1) James Cortright W/M 8-6-96 was arrested on two active Flagler County warrants for Felony VOP. He was additionally charged with obstruction of justice-resisting without violence, after he tried to slam the door shut on deputies that were serving the warrant. The door frame interior trim was damaged upon gaining entry into the cabin. Due to the obstruction charge, D-1 was also charged with an additional VOP.
