Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Larceny (Grand)/67419-16/Home Depot, Palm Coast /Zone 3/ Defendant 1 (D-1) Justin Ryan Sheppard W/M 1-10-83 was arrested for felony retail theft after stealing \$531.50 in merchandise from Home Depot. The property was recovered and returned to the store.

Burglary-Vehicle/67440-16/Wood Crest Lane, Palm Coast / Zone 4/ A neighbor witnessed a suspicious vehicle parked in front of his neighbor's house for a brief moment then drive away. The witness reported it to his neighbor, Victim 1 (V-1), who checked his vehicle to find approximately \$1 in loose change was taken from his vehicle, which was left unsecured.
