### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary-Vehicle/68440-16/ Lakeside Place East, Palm Coast / Zone 3 / Victim 1 (V-1) reported seing a white female enter their vehicle and then leave in a Dodge Ram truck.

Stolen Vehicle-Recovered/68452-16/Bronson Lane, Palm Coast / Zone 3 / Dep. Thomas was canvassing the area regarding a vehicle burglary that had just occurred. Dep. Thomas saw a vehicle matching the description of the suspect vehicle (white Dodge Ram, occupied by a white female). When Dep. Thomas turned around on the vehicle, the suspect turned off the lights and turned down several side streets. The vehicle was subsequently located unoccupied on Bronson Lane. A registration check of the vehicle showed that the vehicle was reported stolen out of St. Johns County. The vehicle was processed for DNA and towed.

Car Breaks/68502-16/ Bayside Drive, Palm Coast. / Zone 3 / Several car breaks were reported and discovered in the area. A resident saw a group of 5-6 black males opening car doors and rifling through the interiors. The males fled on foot when deputies arrived on scene. A perimeter was established. K9 and Volusia AIR ONE responded to assist. Four of the five suspects were apprehended. A handgun was recovered/stolen from Volusia County. ISD called out to assist. Call still active.

Traffic Stop/68430-16/ North State Street, Bunnell. / Zone 6/ Defendant 1 (D-1) was stopped for a minor traffic infraction at the Sunoco Gas Station in Bunnell. While Dep. Gore was checking his driver's license and registration back at his patrol vehicle, Dep. C. Taylor remained in

contact with the driver for officer safety. D-1 then accidentally dropped two baggies of possible narcotics on the floorboard. When Dep. C. Taylor questioned D-1 about the contents of the baggies, D-1 quickly fled in his vehicle, narrowly missing Deputy C. Taylor's foot and two patrol vehicles. D-1 then pulled northbound onto U.S. 1 but in the southbound lanes. Deputies tried to catch up to D-1. He continued northbound at a high rate of speed. Deputies stopped all attempts to apprehend D-1 just north of Royal Palms. Charges signed for aggravated fleeing or eluding. Cmdr. Stuart notified. Pursuit Report form completed.
