### Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Disturbance Domestic (Agg Assault)/ 16-72414/ Victim 1 (V1) reported that Subject 1 (S1) Monique Garcia (w/f 6/16/1983) had chased him with a knife and attempted to stab him. S1 arrested for Agg Assault DV. Once at the jail, S1 introduced contraband (Xanax) into the facility. She then took 40 Xanax in an attempt to hide them from jail personnel. She was taken by ambulance to FHF, medically cleared and transported to the Flagler County jail. Report by Dep West.

Agg Assault on LEO, DUI, crash with injuries, Disorderly conduct/ 16-72418/East S.R. 100, Palm Coast. Deputies Myers and Ebrill responded to a disabled vehicle on the interstate. They transported a subject to the Shell gas station for gas. Once at the gas station, the clerk pointed out an intoxicated male who was disrupting business. While there, the deputies witnessed a severely intoxicated female get into the driver's seat of a gray Toyota minivan. Deputy Myers attempted to stop the female from driving; she accelerated and tried to strike Dep. Myers with her vehicle. Units went to the interstate to BOLO for the vehicle and witnessed the vehicle crash at the 289 mile marker. The male at the gas station (Cody Alan Jones w/m 11/17/88) was arrested for disorderly conduct. He was released and charges were forwarded after he was admitted to Florida Hospital Flagler. The female driver (Charlotte Johnson 04/04/1992) of the minivan, S1, was arrested for Aggravated Assault with a deadly weapon on LEO and Possession of Oxycodone. At FHF, she attempted to escape by slipping a cuff off and running, but she collided with a door and was taken back into custody without incident. FHP responded to work the crash and DUI. Reports by several deputies.
