Commercial Motor Vehicle Fire / 16-77123 / FPL power lines south of Flagler Estates, Flagler County. A reporting person (RP) called to report a 2014 Freightliner line digger vehicle stolen, recovered and found on fire. The RP reported for work this evening (private vendor FPL Line Crew) and observed that one of the vehicles was missing. The vehicle was located 1.9 miles away, flipped on the passenger side, on fire. St. Johns Fire responded; vehicle was totaled and removed from the scene by the company. See report by Deputy Jurec.

Abandoned Vehicle / 16-77135 / FPL power lines south of Flagler Estates, Flagler County. While on scene at above call, the same crew stated that workers found an abandoned vehicle on what appeared to be a makeshift gun range. The vehicle in question was a maroon Toyota Corolla, older model. The vehicle was riddled with bullet holes. The VIN came back surrendered out of New York and car was not reported stolen. It is unknown whose property this was on and if the property controller and the vehicle are related. See report by Deputy Jurec.
