Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary/ 2016-82727/Cardinal Lane, Palm Coast/ Zone 5/ Suspect entered the residence and took money out of victim's wallet. Follow-up investigation to follow. See report by Deputy Rossi for further.

Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Criminal Mischief/2016-82798/Leidel Drive, Palm Coast. /Zone 3/ Reporting person (RP) called and reported hearing a male screaming and possibly windows breaking. When deputies arrived on scene, they discovered a silver Dodge with all the windows shattered and damage to the vehicle. The vehicle was covered in blood from a wound that occurred during the criminal mischief. A blood trail continued down the street to where a dark-colored car was seen leaving the area after striking a vehicle. That vehicle was later located at 64 Rolling Sands with blood on the outside and inside. After making contact on scene, no one would cooperate and said the vehicle driver was not there. The vehicle was towed to the Sheriff's Office evidence for processing. Damage to the vehicle alone is approximately \$2,000. See Dep. Flanery's report for further.

Baker Act (Use of Force)/ 2016-82806/ Bunker View Drive, Palm Coast/ Zone 3/ Deputy Weston responded to this location in reference to a disturbance. Upon deputies' arrival, a male was attempting to hang himself in the bedroom. Deputy Weston deployed his Taser as a last resort to prevent the male from harming himself. The subject was taken into custody without further incident and transported to Halifax under the Baker Act. See report by Deputy Weston for further.
