#### Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Disturbance- Domestic/ 17-1927/ Palm Harbor Pkwy, Palm Coast. A woman, Victim 1 (V1), reported that her husband, Subject 1 (S1), Jahun Johnson, hit her on the right side of her face and grabbed her while the couple was arguing. V1 had visible injuries and S1 had none. S1 was arrested for domestic battery. Report by Deputy Jurec.

Structure Fire/ 17-1942/ Wellington Drive, Palm Coast. A residential structure was evacuated prior to LEO arrival. Fire appears to have started in the chimney while a fire was burning in the fireplace. No injuries reported. Report by Deputy Meehan.

Warrant Service/ 17-1874/ Blairsville Drive, Palm Coast. /S1 (Jonathan Demartino w/m 3-1-81), was arrested on a failure To Appear warrant out of Volusia County. S1 initially tried to run into the house and hide from law enforcement but was taken into custody without further incident. See report by Dep. Butler.

Threats Against LEO/ 17-1990/ S1 (Adam Mohammed o/m 1-5-88) began reporting a verbal disturbance that occurred on West Robin Lane. It became apparent that S1 was attempting to falsely report a disturbance to have deputies retrieve property from the home because he was no longer welcome there. S1 was instructed to leave the gas station where he was reporting the incident because the staff wanted him trespassed
