Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Domestic Disturbance (Physical)/ 2016-107361/ Rosecroft Lane, Palm Coast / Zone 4/ A third-party caller stated that the male on scene battered a 6-year-old child. Upon arrival, a juvenile was observed in the kitchen with a knife while an obvious physical disturbance was taking place inside. Contact was made with Subject 1 (S1), Richard Kinney, who was detained but began resisting officers on scene. The male was arrested and charged with child abuse, domestic battery (striking wife in the face), and resisting without violence. See report by Deputy Santojanni for further.

Domestic Battery/ 2016-107330/ Fellowship Lane, Palm Coast/ Zone 2/ The reporting person (RP) reported that a man took a pack of cigarettes from his wife's purse. She became angry and confronted him. He began to swing his arms striking her in the shoulder and scratching one of their sons who tried to separate them. S1 then fled the residence. Charges will be forwarded. He was unable to be located. See Deputy Collins report for further.

Assualt/Burglary Residential/2016-107366/Point Pleseant Drive, Palm Coast/ Zone 4/The RP called to report that her daughter's ex-boyfriend (Andre Ferreira) suddenly appeared in the garage of the residence while the RP and her daughter were smoking. S1 started a verbal argument with them. They got in the residence and locked the garage door. S1 pulled a screen from a front window and forced entry into the kitchen. Once inside, he backed the RPs daughter against the kitchen sink, yelling and threatening her before leaving. He was later arrested at his residence for burglary and assault.
