Part One UCR Crimes: Type of Call / Case Number / Address / Case Summary

Burglary Residential / 16-70884 / Clove Avenue, Bunnell. Victim 1 (V1) (Shawn Crandall) advised that he was at a neighbor's house last night , Saturday, Aug. 6, when he was attacked by Subject 1 (S1), Donald Mays III, and S2, William Medders. V1 stated he got back inside his residence. Then S1 and S2 kicked his front door, entered his residence and attacked him again and prevented him from calling 911 by taking his phone. V1 had multiple injuries and was diagnosed with a concussion. Upon V1 being released from FHF this morning and returning home, he found S2 in his bed in his bedroom. Fresh boot prints were observed on the front door of V1's residence, consistent with his story. S1 and S2 were arrested for burglary with a battery and tampering with a victim. Disturbance Domestic / 16-70999 / Clove Avenue, Bunnell. S1 (Shawn Crandall) attacked his live-in girlfriend, V1 (Alexandra Cremeans), during an argument Sunday morning, Aug. 7. See report by Deputy Lowe for further.

Sexual Battery / 16-71066 / Unknown - V1 called into dispatch from Georgia advising that she was sexually assaulted at an unknown location in Palm Coast five days ago. See report by Deputy Duenas for further.
